Payment & Cancellation Policy

Registration is only accepted upon completion of forms and 50% payment.

Second payment will be automatically taken on March 26, 2022.

There is a non-re-fundable fee of NIS 850 pp if the cruise is cancelled due to COVID or any "Acts of Nature".

Cancellation fee is per person based on the full price of the trip.

From registration to February 23 – 20%

From February 24 to March 26 – 40%

From March 27 to April 10 – 55%

From: April 11 to May 2 - 75%

From May 3, 2022 – 100%

Traveler's insurance which covers trip cancellation and COVID is required.

Please note that to complete registration **each participant** is required to read carefully, provide what is needed and sign the following declaration:

AACI IMPORTANT AND OBLIGATORY INSTRUCTIONS PRIOR TO TRAVEL

The following instructions must be adhered to. Failing to do so may cause you financial loss and to miss the trip.

Required Covid-19 Procedures

1. You must have a current 'Tav Yarok' (green certificate) in English at time of flying.
2. You are required to take a Covid-19 test **within** 72 hours prior to your flight. This is demanded even if you have received both vaccines and hold a 'Teudat Yarok'. This can be done at Super Pharm, Be Pharm or Ben Gurion Airport. Health Funds are not acceptable for travel outside of Israel. Results must be printed in English to declare upon request by airport/custom authorities.
3. In addition to the Covid19 test, you are required to fill out a Health declaration form via this link **within** 24 hours of your flight from Israel (NOT EARLIER). Confirmation is near instantaneously. Click here: <https://www.gov.il/en/service/request-depart-from-israel-covid19>

Testing upon arrival in Budapest: We are required to take a PCR test ([view PCR details here](#)) upon arrival in Budapest currently without charge.

Passports

Please submit clear copies of all of your passports, Israeli & Foreign ones. Holders of Israeli passports must exit and enter Israel on this passport but can use their foreign on to enter Budapest. Passports must be valid for more than 6 months.

Travel Insurance

You are obligated to take out travel insurance with Covid-19 coverage for the **entire 8 or 9 days** of your travel.

Flying back to Israel

2. You will also be required to take a PCR Test *within 72 hours* of your return flight to Israel. (Arrangements will be made for testing). Each person is required to pay for this test which can be paid in cash or by credit card at the time of the test.
3. Upon returning to Ben Gurion you will need to take an additional Covid-19 test prior to your return flight. Please register for your covid-19 test at Ben Gurion Airport in advance, it will cost NIS80 approx. on-line or NIS100 approx. at the airport: <https://check2fly.co.il/auth>

You must submit copies of insurance, Tav Yarak to AACI before departure. A copy of your negative covid test must be shown to AACI escort at airport before departure.

These requirements are subject to change according to Government Directives.

We wish to kindly remind all registrants again that the above requirements are obligatory and the travelers responsibility. AACI will try to assist you but are not responsible for failure to do so which may cause you financial loss and missing the trip.
