AACI IMPORTANT AND OBLIGATORY INSTRUCTIONS PRIOR TO TRAVEL

The following instructions must be adhered to. Failing to do so may cause you financial loss and to miss the trip.

Required Covid-19 Procedures

1. You are required to take a Covid-19 test **within** 48 hours prior to your flight. This should be done on Saturday even, March 18, 2022. This is demanded even if you have received both vaccines and hold a 'Teudat Yarok'. This can be done at Super Pharm, Be Pharm or Ben Gurion Airport. Health Funds are not acceptable for travel outside of Israel. Results must be printed in English to declare upon request by airport/custom authorities.
2. In addition to the Covid19 test, you are required to fill out a Health declaration form via this link **within** 24 hours of your flight from Israel (NOT EARLIER). Confirmation is near instantaneously. Click here: <https://www.gov.il/en/service/request-depart-from-israel-covid19>

Testing upon arrival in Dubai: We are required to take a PCR test ([view PCR details here](#)) upon arrival in Dubai without charge.

Passports

Please submit clear copies of all of your passports, Israeli & Foreign ones. Holders of Israeli passports must exit and enter Israel on this passport but can use their foreign on to enter Dubai.

No fee for UK/USA passport holders.

Passports must be valid for more than 6 months.

Travel Insurance

1. You are obligated to take out travel insurance with Covid-19 coverage for the **entire 9 days** of your travel. Failure to do so will void your booking.

Flying back to Israel

1. Please fill this link out **within** 24 hours of your flight **BACK TO** Israel:

2. You will also be required to take a PCR Test **within 72 hours** of your return flight to Israel. Tests will be given at the hotel. Each person is required to pay \$55 which can be paid in cash or by credit card at the time of the test.
3. Upon returning to Ben Gurion you will need to take an additional Covid-19 test prior to your return flight. Please register for your covid-19 test at Ben Gurion Airport in advance, it will cost NIS80 approx on-line or NIS100 at the airport: <https://check2fly.co.il/auth>

You must submit copies of insurance, Tav Yarok to AACI before departure. A copy of your negative covid test must be shown to AACI escort at airport before departure.

These requirements are subject to change.

We wish to kindly remind all registrants again that the above requirements are obligatory and the travelers responsibility. AACI will try to assist you but are not responsible for failure to do so which may cause you financial loss and missing the trip.
